## RULES AND REGULATIONS

- Water meters and readers must be removed by the City Public Works Department. Provide two days notice.
- All abandoned wells on the property must be sealed by a licensed well drilling contractor
- Abandoned fuel oil and gas tanks must be removed by a state licensed contractor, a separate permit must be obtained for tank removal, contact the Fire Marshal for inspections. City water must be disconnected and properly capped at the curb stop. Sanitary sewer must be disconnected and capped at the property line or beyond demolition limits if the intent is to reuse.
- Silt fence must be in place before demolition begins. Storm drains must be protected to prevent silt or debris from entering.
- Provide tree protection at the drip line of all trees over 4-inches diameter located near the area of demolition.
- Site shall not be backfilled until the Building Official inspects and approves site for backfilling.
- Remove all debris from the property within 7 days from completion of demolition and make certain that the property is clear of all hazards after demolition and cleanup.
- Property shall be leveled to meet the contour of the adjacent properties to prevent runoff.
- Ground surface area of property shall be landscaped in keeping with the appearance of adjacent properties.
- Property shall be developed either with turf or an acceptable alternative that has been approved by the City.
- The refuse company must be licensed to do business in the City of Excelsior.
- Before a permit is issued, the application shall:
  - Submit plans for the reuse of the property on which the building or structure to be demolished is located to ensure that it is compatible with Zoning and Comprehensive Plan requirements.
  - Obtain a building permit, if necessary, for the construction of any structure or building.
